1. **Sakela Rural Municipality, Office of Rural Municipal Executive, Manebhanjyang, Khotang, Nepal** has allocated funds from Government of Nepal towards the cost of **Construction of Sakela Primary Hospital at Ratanchha, Khotang** and intends to apply part of the funds to cover eligible payments under the contract stated below. Bidding is open to all eligible Bidders as per Section V of bidding document.
2. **Sakela Rural Municipality, Office of Rural Municipal Executive, Manebhanjyang, Khotang, Nepal** invites **electronic bids** from Eligible and Qualified bidders for the construction of the Project mentioned in table below under **National Competitive Bidding – Single Stage Two Envelope** Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at **Sakela Rural Municipality, Office of Rural Municipal Executive, Manebhanjyang, Khotang, Nepal** at 17:00 hrs on 22 Chaitra, 2077 (4 April, 2021).
7. Electronic bids (one Technical Bid and other Price Bid) must be submitted through PPMO's eGP system www.bolpatra.gov.np/egp on or before 12:00 Hrs. on 3 Baishakh, 2078 (16 April, 2021). Bids received after this deadline will be rejected.
8. The Technical bids will be opened electronically in the presence of Bidders' representatives who choose to attend at 14:00 Hrs. on 3 Baishakh, 2078 (16 April, 2021) at **Sakela Rural Municipality, Office of Rural Municipal Executive, Manebhanjyang, Khotang, Nepal**. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned in the table in clause 2 above, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Matters not covered by this notice shall be in accordance with Public Procurement Act, 2063 with amendment and Public Procurement Regulations, 2064 with amendment and other prevailing regulations. **Sakela Rural Municipality, Office of Rural Municipal Executive** reserves the right to accept or reject wholly or partially or all the bids without assigning any reasons whatsoever.
